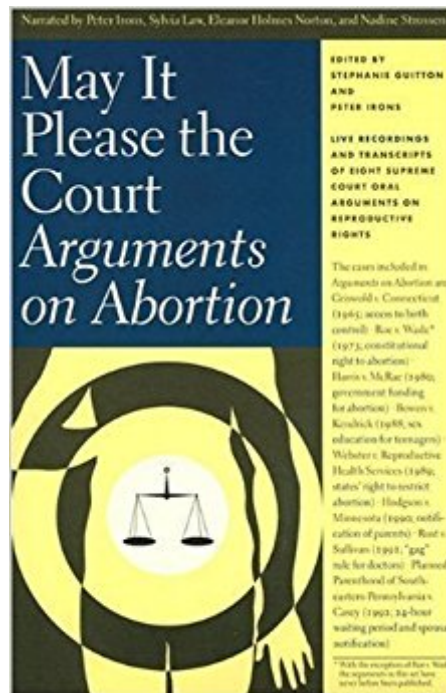

The first title in this series, *May It Please the Court: The Most Significant Oral Arguments Made Before the Supreme Court Since 1955* (Audio Reviews, LJ 10/1/93), was published amid controversy since the tapes were, technically, bootlegged. Eventually, the Supreme Court accepted the public's right to hear history being made. The publisher is capitalizing on the popularity of the first set with this more narrowly focused anthology. Included are eight Supreme Court cases on abortion dating from 1965 to 1992, including the landmark *Roe v. Wade* (1973). The recordings are slightly edited, with added narrative by Sylvia Law, Nadine Strossen, and Eleanor Holmes Norton that provides contextual information. The quality of the recorded speeches is fairly good, and the accompanying paperback book contains the complete transcript. Recommended for women's studies collections and larger public libraries. Note: The set comes in a flimsy cardboard box with a Styrofoam™ insert for the cassettes, so libraries will have to be innovative in processing for circulation. ?Nann Blaine Hilyard, Fargo P.L., N.D. You might expect a book full of court transcripts dull; in fact I thought it would be a little dry. But I've been amazed by this book. I picked it up on a sale table in a book store - and came here to see if I could find more in the series - One thing strikes you right away - Supreme Court justices are SMART. The second thing that strikes you is that they have a huge amount of power, but are subject to the same prejudices and personal attachments that affect us all (especially with regards to abortion). You can see them grapple with deeply personal issues. It's fascinating (and sometimes even witty) to read the chronology of court cases before, including and after Roe v Wade. You can clearly see how abortion law has evolved. The book definitely has a pro-choice slant, so if you're expecting a pro-life diatribe, this isn't your book. The language is clear and easy to read without the kind of legal mumbo-jumbo we're used to hearing in movies. This has been an enriching read, one that makes me feel profoundly human, fallible, and American.
