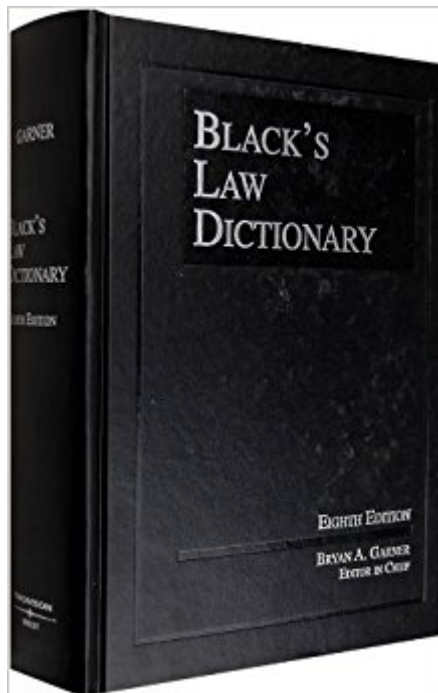

You'll also gain access to an online version of Black's through any Westlaw account, but it's one version behind, and the UI isn't as easy to navigate. I think the hardcover dictionary is worth the money. Finally, a word about the Deluxe Edition: no. I can't see paying almost double for what it offers.
